

**GOODNESTONE PARISH COUNCIL
MINUTES OF MEETING
WEDNESDAY 23rd NOVEMBER 2011**

Present

1. Apologies

There were no apologies to report.

2. Minutes of the Meeting of the 14th September 2011

The Clerk agreed to follow up District Councillor Conolly's report regarding PILE OFF, high-speed broadband for Thanet and the revision of boundaries for constitution areas.

3. Matters arising not covered elsewhere in the Agenda

It was agreed that the recent issues regarding dog fouling and dog control will be monitored but that no further action be taken at this stage.

4. Community Policing

PC Callaghan had intended to attend the meeting but was unable to. The Council had nothing to report.

5. District Councillors invited to report on DDC

No district Councillor was able to attend the meeting.

6. Goodnestone CE Primary School

The School new-build is progressing and is on schedule. The Council are invited to attend the opening ceremony on January 5th.

7. Affordable Housing Scheme

Applications are now closed and English Rural is drawing up a shortlist to interview. Kathryn Watson will contact the Clerk with a list of applicants in order that the Parish Council can verify the claimed local connections. Successful applicants will be contact before Christmas. The development is still on schedule to be completed by March 5th 2012.

8. Village Website

All Councillors liked the website created by Jon Aldington. The Clerk agreed to contact all local clubs / societies to inform them of its existence so that events can be advertised on it. The Clerk agreed to email the minutes from the last 12 months of Council Meetings as well as the welcome pack in electronic form to be updated and put on to the website.

9. Planning

Proposal: Erection of a single storey side extension. Location: 2 Uffington Court Cottages, Adisham Road. The council agreed a response of ambivalent.

10. Footpaths

There was nothing to report. The Clerk is to look into claims that footpath stiles are being phased out.

11. Highway Matters

The Clerk agreed to ask Nick Parsons if he could assist in the replacement and filling of salt bins in Rowling and on the junction of Cave Lane and Goodnestone Road, using the 1T bulk bag of salt delivered recently by Kent Highways for use at the discretion of the Parish Council.

Councillor Plumptre agreed to meet any representative from Kent Highways available in order to solve the drainage problems on the sharp bend on Cave Lane and at the bottom of The Street. The Clerk will contact Kent Highways to see how they suggest moving this forward.
