# 1. Apologies

Apologies were received from Councillors Plumptre and Ellison.

# 2. Minutes of the Meeting of the 22<sup>nd</sup> January 2014

The minutes of the meeting were signed by the Vice Chairman (Councillor Phillips) as a true record of events.

# 3. Matters arising not covered elsewhere in the Agenda

Councillor Phillips reported that he is liaising with Vogt Solar to establish whether the community fund could be used to improve disabled access to the church, a priority for the village. Councillor Phillips has made arrangements to meet Nick Barnes and Nick Parsons to discuss the work.

The Clerk made the Council aware of a report of vandalism at Boyes House. The clerk was unsure whether the owner had reported this matter to the police.

# 4. District Councillors invited to report on DDC

District Councillor Bartlett reported the following:

#### **Charges**

The council met in March and agreed that there will be no increase in council tax this year. Parking charges have also been frozen, something that he hopes will be repeated next year.

## **Land Allocations**

The Inspector has finished their report, which featured a significant number of representations. The final report will be released at some point in the spring.

#### Preston & Salvatori

Following the public open evening of 21<sup>st</sup> March where Preston residents were able to voice strong opposition to the original proposals, the number of planned new homes has been reduced from 120 to 80. There remains strong local opposition to the plans.

# **Discovery Park**

The park is still attracting new companies. The 'life plan' for the park features provision for a range of commercial organisations, together with life science and light engineering companies. There are also plans for housing and a supermarket (Sainsbury's has submitted plans).

#### 5. Community Policing

Councillor Phillips pointed out that since there are currently two sets of building works taking place on Short Street properties, it is difficult to differentiate between construction-related and agricultural mess.
