#### **5.HIGHWAY MATTERS**

- 1. Municipal Planters Proposed planters shared with Councillors. Volunteer required to look after Chillenden and Goodnestone. Vote to proceed cast Resolved. NTB and KP to measure up and propose costings to the PC at the next meeting. (Action 002)
- 2. Information Board Proofs reviewed by the PC, feedback given. KP to follow up with designers and agreement at the meeting the designs can be approved outside of the PC (Action 003)
- 3. Speed reductions 20mph limit signs are in place in Goodnestone, Chillenden will be complete on 20<sup>th</sup> October 2022.
